ORDER FOR SOLE OWNED POLE LOCATIONS

By the Board of Selectmen of the Town of Lynnfield, Massachusetts

Notice having been given and a public hearing held, as provided by law,

IT IS HEREBY ORDERED:

That the PEABODY MUNICIPAL LIGHT PLANT be granted sole location for and permission to erect and maintain poles and it's respective wires and cables to be placed thereon, together with anchors, guys and other such sustaining and safeguard fixtures as said Company may deem them necessary, in the public way or ways at the locations as requested in petition of said Company dated the 10th day of May, 2017.

All construction under this order shall be in accordance with the following conditions: Poles shall be of sound timber, and reasonably straight, and shall be set substantially at the points indicated upon the plan marked – PMLP No. 16-186, dated the 10th day of May, 2017 filed with said petition. There may be attached to said poles by said PEABODY MUNICIPAL LIGHT PLANT wires and cables as necessary in the conduct of their business, and all of said wires and cables shall be placed at a height of not less than 18 feet from the ground. The petitioner is hereby required to reserve one foot of space on each pole referenced in this order for attachment of Fire, Police, data transmission, and telecommunications signal wires belonging to the Municipality and used by it exclusively for Municipal Purposes. In addition, the petitioner is required to reserve vertical space on each such pole to accommodate Municipally owned underground conduits and signal wires to be connected in the reserved Municipal Space.

The following are the public ways or parts of ways along which the poles above referred to may be erected, and the number of poles, which may be erected thereon under this order:

For the installation of a Guy Stub Pole, to be designated Pole No. 7S at a point 33 feet to the West of the existing location of Pole No. 7, this being along the Westerly side of Locust Street.

Also, that permission be and hereby is granted to said Company to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each may desire for distributing purposes.

Notice is hereby given that the Board of Selectmen of the Town of Lynnfield will hold a public hearing at 7:00 p.m. on Monday, June 26, 2017, in the Al Merritt Media and Cultural Center, 600 Market Street, on the following petition:

In accordance with Chapter 166, Section 22 of the General Laws of Massachusetts, by petition of said Company dated the 10th of May, 2017, and plan marked PMLP No. 16-186, dated the 10th day of May 2017, and filed with said petition, Peabody Municipal Light Plant requests permission to locate poles, wires, cables and fixtures, including the necessary anchors, guys and other sustaining and protective fixtures to be owned and used in common upon, along, under and across the following public way or ways:

LOCUST STREET

Install a Guy Stub Pole, to be designated Pole No. 7S at a point 33 feet to the West of the existing location of Pole No. 7, this being along the Westerly side of Locust Street.

Also for permission to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and building as each of said petitioners may desire for distributing purposes.
