I have been asked to request a continuance of the public hearing from the September 28, 2022 Lynnfield Planning Board's meeting to its October 26, 2022 public meeting without taking testimony on the Vallis Way Subdivision matter.

As mentioned last month: The reason for this continuance request is based on this explanation from Peter Ogren: "Confirming a discussion on Friday August 12 the geotechnical firm doing the analysis for the basin was sidelined with Covid and needs additional time to do testing to verify some of the parameters utilized: As a consequence we are not making the changes to the definitive plan for submission this week, and there will not be sufficient time for Bill Jones to review the information (prior to the September meeting). We would like to amend the schedule to provide all information by the middle of next month (October), anticipating final approval at the October 26th regularly scheduled Planning Board meeting."
