Wakefield / Lynnfield Rails to Trails Project Update

The Wakefield / Lynnfield Rails to Trails project is moving forward with an anticipated twenty-five (25) percent submittal to the state this summer. This project as proposed provides a 4.4-mile recreational multi-use trail along the MBTA rail corridor beginning at the Galvin Middle School in Wakefield, and extending through Lynnfield to the Peabody City line. In April 2014 public information meetings were held in each community to discuss the proposed project and obtain community input. Since that time, the design has advanced to a preliminary design stage in preparation of a submittal to the Massachusetts Department of Transportation, who will ultimately fund the construction of the project through the State Transportation Improvement Program (STIP).

Over the past several months, the design team has performed geotechnical investigations and analysis, completed hydraulic modeling of the watershed, began environmental assessments, evaluated options for Crossing the Reedy Meadow, and progressed the design elements of the trail which include the horizontal and vertical alignment of the trail, at-grade street crossing configurations, trail amenities and features, and began to develop screening alternative treatments along the path. One keynote related to the design, our original thought was to utilize abandoned rail cars through the meadow for the trail. This approach is proving to be less practical and more costly than originally anticipated. Therefore, we will utilizing an elevated timber boardwalk structure for the meadow crossing.

The next steps in the process include holding neighborhood input meetings in Wakefield and Lynnfield to present the current design and solicit input as the design team works towards a Preliminary (25%) design submittal to MassDOT this coming summer. Upon review and approval of this submittal, MassDOT will then hold an official Design Public Hearing to present the project as part of their formal design process. The anticipated dates for the public meeting are the following: Lynnfield (1/12/16) and Wakefield (1/13/16).

EMERGENCY AND DISASTER PLANNING FOR ELECTION POLLING PLACES

In the event that the election poll needs to be evacuated for any period of time, the following procedures should be followed <u>IF CIRCUMSTANCES ALLOW</u> (based on the direction of emergency personnel).

SAFETY OF VOTERS AND POLLWORKERS IS THE TOP PRIORITY

BALLOTS BEING USED BY THE VOTER: All ballots must be accounted for and secured prior to leaving the building.

• DO NOT permit voters to remove ballots from the polling place.

Place the ballots in the spoiled ballot envelope and record the names of the voters on the back of that envelope. When you re-enter the polling place, give the voters who were voting at the time of the evacuation new ballots, using the spoiled ballot envelope as a guide to check off the voter's name. Remove all ballots from the spoiled ballot envelope and mark them "Spoiled" and return to the envelope.

<u>VOTING LISTS AND UNUSED BALLOTS</u>: The voting lists and all unused ballots must be secured before leaving the building.

DO NOT leave unused ballots unattended during an evacuation.

Place all unused ballots, all voting lists and the spoiled ballot envelope into the ballot carrier under the check-in table at each precinct. LOCK the box and take the Precinct keys with you.

When re-entering unlock the box and note the reason, time, and duration of the evacuation in the Clerk's notes.

Emergency and Disaster Planning for Election Polling Places (Continued)

VOTING EQUIPMENT: The voting equipment itself must be secured.

UNPLUG THE EQUIPMENT

Wardens should take their machines with them when they evacuate the polls. Make sure all doors are locked on the ballot box, and the counter is secured in place before moving the entire machine.

VOTERS MAY CAST AN ABSENTEE BALLOT AT THE TOWN CLERK'S OFFICE DURING THE TIME THE POLL IS EVACUATED

Note on the application, the reason for voting in the office.

LASTLY, be sure that everyone has left the polling area –

the Police, Wardens, and Clerk should be the last to leave!

The Town Administrator, Police Chief or the highest ranking officer available should be notified as soon as possible.

In the event, the emergency at the poll cannot be rectified within 60 minutes of the evacuation; the election will be moved. Election Officers should move as quickly as possible to the alternate poll and bring whatever materials they were able to carry out of the poll at the time of evacuation. DPW will be called upon to assist in the move. (781-334-9500)

Unless otherwise stated the relocation point will be the Lynnfield Middle School

Emergency and Disaster Planning for Election Polling Places (Continued)

In the Event of Fire:

- 1. Call 911, evacuate the building immediately.
- 2. Call State Elections Division to notify them of situation 617-727-2828
- 3. Election Warden and the Town Clerk will secure election voting boxes, and record number of votes indicated on each tabulator
- 4. Election Officers Check In...secure unused ballots, and check in voter lists, and as you leave building, take with you. Keep with you until you can safely turn over to Election Warden or the Town Clerk
- 5. **Election Officers Check Out** secure check out voter lists, and as you leave building, take with you. Keep with you until you can safely turn over to Election Warden or the Town Clerk
- 6. **Election Clerk** safely secure paperwork on working table to include any unvoted absentee ballots, absentee ballot report, election books, etc. As you exit building, take what you can and keep with you until you can safely turn over to Election Warden or the Town Clerk
- 7. The Town Clerk will notify the Town Administrator when safely possible 781-334-9410. Town Administrator's office should put out a Reverse 911 call to all resident informing them of the location change for voting purposes.

In the Event of Power Outages:

- 1. Notify building maintenance and DPW **781-334-9500**
- 2. Call State Elections Division to notify them of situation -617-727-2828
- 3. **Election Warden and the Town Clerk** should ensure voting machines are running properly on backup battery.
- 4. The **Town Clerk** will notify the Town Administrator's Office when safely possible **781-334-9410**. Town Administrator's office should put out Reverse 911 call to all residents informing them of the location change for voting purposes (if necessary).
