End of Year Transfers

- S§ 75-76 Amend G.L. c. 44, § 33B regarding appropriation transfers at year-end (May 1 July 15) by selectboard and finance committee in towns and city council upon mayor's recommendation
- Eliminates 3% cap on year-end transfers from departmental line items
- Allows year-end transfers from nondepartmental line items
- Year-end procedure still does not apply to school and light departments



Approval of Departmental Bills

- *§ 58 Amends G.L. c. 41, § 56 regarding approval of departmental bills and payrolls
- Allow department head that is multi-member board or committee to designate 1 member to reviev⊯and approve departmental bills
- Member must report to full board at next meeting
- Mirrors G.L. c. 41, § 41 which allows multimember board or committee to designate 1 member to approve departmental payrolls



Approval of Treasury Warrants

- *§ 57 Amends G.L. c. 41, § 52 regarding approval of treasury warrants for payment of bills and payrolls
- "Allows selectboard to designate 1 member to approve treasury warrants in towns
- Member must report to full board at next meeting

Dear Mr. Curtin,

It was nice speaking with you in your office a few weeks ago. Thanks for your time. To refresh your memory, I am the race director for Calvary Christian Church's Running and Walking Well 5K. We have held the race for the last three years in May at Lynch Park in Beverly. All of the funds we have raised over the last three years have gone towards digging five wells in Kenya, Tanzania and Ghana.

This year we would like to move the race closer to our church and have the race take place in June. The race is also a family day for the runners, walkers, spectators and families. At Lynch Park we had music, games for the kids, a silent auction and free food. There is a fee to run or walk but there is no fee to attend the event and all are welcome.

Per your suggestion, I have checked with Lynnfield's Recreation department about the availability of the fields at our Middle School and June 24th seems to be the best day for everybody. We would not need access to the school at all. We would have four portable toilets dropped off on June 23rd and they would be picked up June 26th. We would most likely rent a generator like we did for the movie night we had at the Middle School field in August. We would have an ambulance there and would hire any police details needed.

We would arrive at the middle school at 6:30AM to set up, open the event to the public at 7:30AM and start the race in the parking lot at 9:30AM. Would would conclude the event by 2:00 PM and clean up. We would bring our own trash barrels and take all the trash with us. We would leave the field as we found it.

As far as the course, it would a 3.1 mile course and we would have course marshals at the major intersections to direct runners and walkers and to keep everybody safe. We would hire as many police details as suggested. Below is the suggested course but we are open to any suggestions.

Start in the Middle School parking lot
Take right onto Main St.
Take right onto Essex St
Left onto Yorkshire Dr
Left onto Chatham Way
Right onto Homestead Rd (which turns into Oxbow Rd)
Right onto Essex St.
Left onto Main St.
Left into the Middle School were the finish would be.

We tried to create a course in which runners and walkers would be off the main roads as much as possible but we are open to any suggestions your Police Department might have. If there are any fees for renting the field, please let me know so we can include them in our budget.

I think you mentioned that our event has to be voted on at a selectmen's meeting. Could you please tell me when your next meeting is and if you see any issues with our event proposal.
