How to obtain a Solicitor's and Canvasser's License in the Town of Lynnfield

Bring completed application to the Town Clerk's Office with a State Issued Identification, and two (2) 2" x 2" passport quality photographs. (*Note:* computer printed pictures on paper are not acceptable). Each person applying must appear. The filing fee is 10.00 each

The license fee is not accepted during the application process, only when the license is issued.

Either call (781-334-6505) or stop by the Lynnfield Police Department to make an appointment to be fingerprinted. Each person applying for a solicitor's license in Lynnfield must be fingerprinted. The fee for fingerprinting is \$100.00.

Once the application has been approved (or disapproved) you will be contacted.

When picking up the approved license, you may pay the applicable license fee:

\$10.00 per day \$7.00 per week \$30.00 per month \$300 per year
